

LICENSE AGREEMENT FOR RDL'S Q-SYS™ PLUG-IN: DD-BTN44 and D-BTN21

This License Agreement (the "Agreement") is a legal agreement between you, the end-user ("Licensee"), and Radio Design Labs, LLC. ("Licensor") for the use of the RDL Q-SYS Plug-In: DD-BTN44 and D-BTN21 ("Software") for the defined use of configuring compatible RDL modules individually and in multiple module systems. Use or storage of this Software or its associated documents on a computing device constitutes your agreement to be bound by the terms of this Agreement. Further, Licensor may update the terms of this Agreement, and it is Licensee's responsibility to check back for updates. Licensee's continued use of the Software after any such update constitutes Licensee's acceptance of the updated Agreement.

GRANT OF LICENSE Subject to the terms and conditions of this Agreement and the Licensee's compliance therewith, Licensor hereby grants, and Licensee hereby accepts, solely for the defined use, a non-exclusive, non-sublicensable and non-transferable license to the Software and Documentation.

OWNERSHIP Licensee acknowledges and agrees that the Licensor is and will remain the sole and exclusive owner of all rights, title, and interest in and to the Software, Documentation, Version Updates and all associated Intellectual Property Rights, subject only to the rights of any Open-Source Components, any third parties and the limited license granted to Licensee under this Agreement. You may not modify, rent or resell for profit this Software, or create derivative work based upon this Software. Licensee also acknowledges that Licensor is the owner of any and all Intellectual Property relating to the Software, including any trademarks, logos, patents, copyrights, domain names, social media accounts, and the like. Licensee agrees not to acquire or use any confusingly similar trademarks, domain names or social media accounts.

Software Licensee may not modify, translate, reverse engineer or de-compile the Software. Licensor may update, revise or discontinue the Software and/or products controlled by the Software at any time without notice to you.

EXPORT

Licensee acknowledges that the Software may be subject to applicable United States export Laws and Licensee agrees to comply with all provisions of such export Laws. Licensee shall not itself or permit any third party to directly or indirectly export, re-export, or release the Software, or use the Software in any country prohibited or restricted under United States export Laws.

GOVERNING LAW

This Agreement is governed by and construed in accordance with the Laws of the State of Arizona without giving effect to any choice or conflict of law provisions or rules that would permit the application of the laws of any other jurisdiction. Licensee agrees that the exclusive remedy for all disputes and claims relating in any way to, or arising out of, this Agreement, or Licensee's use of the Software, shall be final and binding arbitration conducted in, and under the laws of, the State of Arizona.

Severability

In the event that any portion of this Agreement is held to be unenforceable, the unenforceable portion shall be stricken or amended to reflect, to the greatest extent permitted under applicable law, the original intent of the parties, and the remainder of the provisions shall remain in full force and effect.
